HEATS WILL TAKE PLACE ON FRIDAY AND SATURDAY MORNING WITH THE TOP 15 TIMES GOING ON TO THE FINALS STARTING AT NOON ON SATURDAY.

1. To participate in this event, Loader Operators must be an SCLC member and are required to be sponsored by a company or be an owner/operator.
2. Must abide by rules of the competition.
3. Must complete and sign entry form.
4. Only those contestants that have registered for the competition will be allowed to participate. There will be no substitutes for any contestant.
5. A three judge panel will oversee the competition and their

- decisions will be final. If any questions or discrepancies arise that are not covered in the rules and regulations, the panel of judges will make a decision that will be final.
6. If there are problems with the loader during the competition, a contestant may be allowed to start over with either new or repaired equipment.
 7. All competitors should conduct themselves as professionals. Use of profanity will result in a 10 second penalty. Unsportsmanlike behavior could result in disqualification.
